The Sweepstakes is subject the following full official rules (the "Official Rules") which incorporate the information and defined terms set forth above; by entering, entrant ("Entrant") agrees to be bound by them and the decisions of G&S, which are final and binding in all respects.

**1. **2. Upon completion of this process, each eligible Entrant will receive one (1) entry in the Sweepstakes. All entries must be received during and by the end of the Sweepstakes Period. G&S's computer is the official timekeeping device for entry in the Sweepstakes. There is a limit of one entry per person. Normal time rates, if any, charged by the Entrant's Internet service or mobile provider will apply.

The odds of winning depend on the total number of eligible entries received within the Sweepstakes Period.

When submitting their entry, Entrants are required to provide complete and truthful information. Entries that are incomplete, illegible, corrupted, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at G&S's sole and absolute discretion. **5. Winner Selection and Notification:** The potential "Winner(s)" for the Sweepstakes will be determined via a random drawing, from all Eligible Entries received during the Sweepstakes Period, within ten (10) business days of the end of the Sweepstakes Period. The number of potential Winner(s) shall be same as the number of Prize(s) listed, and if designated, there may be differing levels of Prizes and therefore differing levels of Winners. Each applicable Prize will be awarded to the authorized account holder of the email address submitted with the entry regardless of the individual who submitted the winning entry. The authorized account holder is the person who is assigned to the e-mail address by an Internet service provider or other organization that is responsible for assigning e-mail addresses or the domain names associated with e-mail addresses. The potential Winner(s) will be notified within three (3) business days of the drawing. The potential Winner(s) will be notified by email (at the email address provided with the entry), and will be required to confirm his/her email address. If the potential Winner of a Prize cannot be reached after a reasonable effort has been exerted and/or fails to respond to confirm his/her email address within three (3) days from when the initial notification email is sent, the potential Winner forfeits the applicable Prize, and an alternate potential Winner for the applicable Prize will be randomly drawn from all remaining Eligible Entries received during the Sweepstakes Period. If the alternate potential Winner is unable to accept the applicable Prize, that Prize is forfeited and another alternate potential Winner for applicable Prize will be randomly drawn from all remaining Eligible Entries received during the Sweepstakes Period. **6. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in the Sweepstakes-related materials, privacy policy or terms of use on a website and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control and the discrepancy will be resolved in G&S's sole and absolute discretion.
